AT AN ASSEMBLY of Electors of the Parish of St. Ouen, duly convened and held in St. Ouen's Parish Hall on Wednesday, 28 August, 2024 at 7.00 p.m. to:-

- 1. Receive and if deemed advisable, approve the Act of the Parish Assembly held on 25 July 2024.
- 2. To consider the following application to the Assembly of Governor, Bailiff and Jurats for 2024.

Category 6th Category (off licence)

The Connétable welcomed those present and gave apologies from Advocate Richard John Michel (Member of the Roads Committee).

The Connétable then asked the Parish Secretary to read the convening notice.

The Connétable moved on to item 1 of the agenda and advised that the minutes of the Parish Assembly held on 25 July 2024 are available on the chairs. The minutes were approved unanimously on the proposition of Allan John Quenault (Procureur du Bien Public), and seconded by Mr Royston Stanley Le Bas (Procureur du Bien Public).

Item 2 on the agenda was to consider a licensing application for Batch Limited for a 6th category (off licence). The Connétable advised the Assembly that he had received confirmation from Jersey Fire and Rescue and Environmental Health Department that an inspection report is not required for 6th category off licence applications.

The Connétable then asked if a representative of Batch Limited would like to introduce themselves and address the Assembly. Mr Richard Fraser advised the Assembly that the company import craft beer from the UK and had previously operated from the Parish of St Brelade. Each

month, they would be importing different beers, so the retained stock held on the premises would be minimal, as they operate on a supply and demand basis.

Mr Allan John Quenault (Procureur du Bien Public), asked if the company operated solely online, to which Mr Fraser replied they did. The Connétable then asked for a proposer and seconder. Mr Clifford Anthony Fraser duly proposed the application, which was seconded by Mrs Elizabeth Fraser and was approved unanimously by the Assembly.

The Connétable explained to the Assembly that the minutes and relevant documentation will now be prepared and forwarded to the Judicial Greffe for recommendation to the Licensing Bench. The Connétable reminded all parishioners that had spoken this evening were permitted to attend and speak at the Assembly in the Royal Court at 09:30 on Thursday, 26 September 2024.

Finally, the Connétable asked for a proposition that the minutes of this Assembly are to be approved at the next Parish Assembly. Mr Allan John Quenault (Procureur du Bien Public) duly proposed the motion, which was seconded by Mr Royston Stanley Le Bas (Procureur du Bien Public).

There being no further business, the President declared the meeting closed at 7.05 p.m.
